

“PICK THE WINNER FOR DINNER” PROMOTION

Windy Hill Venue

Terms and Conditions of Entry

- 1. Terms and Conditions:** Information on how to enter and prizes form part of the Terms and Conditions of Entry. Participation in the *Pick The Winner For Dinner* Promotion (“Promotion”) is deemed acceptance of these Terms and Conditions of Entry.
- 2. Promotion Period:** Entry into the Promotion will be offered prior to the first bounce of the football in selected AFL matches during the 2021 AFL season (including Finals). The Pick The Winner For Dinner competition for each match will run as a separate Promotion. The Promotion Period for each Promotion will start at the time the Pick The Winner For Dinner Facebook post appears on Facebook, and will conclude at the time of the first bounce for the selected AFL match (“Promotion Period”).
- 3. Eligibility:** To be eligible to enter this Promotion, Entrants must meet the following criteria:
 - a) be a Facebook user, and
 - b) be aged 18 years or over and reside in Australia, and
 - c) visit the Essendon Football Club Windy Hill Venue (“Venue”), and
 - d) “Like” the Essendon Football Club Windy Hill Venue Facebook page by selecting the “Like” icon at facebook.com/essendonwindyhill.socialclub during the Promotion Period. Customers who have previously selected the “Like” icon at facebook.com/essendonwindyhill.socialclub will also be eligible to enter. Entry is not open to employees of the Venue or agencies associated with this Promotion. Entry is subject to Entrants meeting the conditions of venue entry at the Venue.
- 4. Entry:** To enter, Entrants must:
 - a) Visit facebook.com during the Promotion Period and locate the post from [essendonwindyhill.socialclub](https://facebook.com/essendonwindyhill.socialclub) inviting entrants to comment on that post to indicate a winning team and margin for a selected AFL game.
 - b) Prior to the first bounce of the football in the selected match, the Entrant must comment on this post with i) the name of the AFL team that will win the selected match and ii) the margin that the selected team will win this match by. There is a limit of one entry per Entrant.
- 5. Judging:** The Winning Entry will be the Entrant whose entry (as per Clause 4) matches the winning team and final winning margin result of the selected AFL match. If more than one entry is correct, the Winner will be the earliest correct entry received, based on Facebook post date and time. If no correct entries are received, the Prize will not be awarded.
- 6. Prizes:** The Winner (as selected based on clause 5) will receive a voucher for Dinner For Two (2) People at the Windy Hill Venue Terrace Bistro*, which includes any two (2) main meals on the Main Menu or Specials Board on the night the Winner attends the Venue. Total value of the Prize is up to \$84.00. *Refer to Clause 7 for terms and conditions of the prize.
- 7. Prize Terms and Conditions:** Prize is not transferable and not redeemable for cash. The voucher has a one (1) week validity from when the Winner is announced. Prize must be redeemed in one sitting and cannot be split. Please refer to the Voucher for other conditions of use.
- 8. Notification & Delivery:** Prize Winner will be notified via Facebook and published at facebook.com/essendonwindyhill.socialclub within 24 hours of the conclusion of the Promotion Period. The Prize will be available for collection from Reception at the Windy Hill Venue for one week.
- 9. Facebook Limitation:** This Promotion is in no way endorsed, sponsored or administered by Facebook. By participating in this Promotion, Entrants release Facebook from any liability associated with this Promotion.
- 10. Verification of Entries:** The Promoter reserves the right, at any time, to verify the validity of claims/entries and claimants (including the Entrant’s age, identity, place of residence, membership status and employer) and to disqualify any Entrant who submits a claim/entry that is not in accordance with these Terms and Conditions of Entry, or any Entrant who tampers with the entry or claims process or who may benefit from such tampering.
